






GRADUATION DATES

The Oregon Society of CPAs asks recent graduates to confirm their graduation date.


- Those who graduated keep their free membership for another year.
- Those still in school can provide a new graduation date and confirm their University.






PERSONAL EMAIL ADDRESS



Those that said "yes" or "possibly" got an email they could forward on to their students.




LAPSED STUDENT WIN-BACK
